Treasurer's Report- Kip Stevenson

- Profit and Loss a report coming directly from Quick Books
- Quickbooks go back to 2008
- Income from Jogathon: \$39,793.00
- Book Fair brought in \$4,511.00
- Boo Bash \$66
- Misc Donation: \$6,000. Waiting for a letter, but intended to be restricted for enrichment.
- Expense for OBOB
- School directory: Advertising funds, but it usually pays for itself.

- Appreciate the volunteer support!
- Celebrating integrity this month (doing the right thing even when someone isn't watching you)
- BEA Rep, Mrs. Cholton is the new rep. There is an initiative ballot to increase funding for Oregon schools
 - Oregon has the 3rd largest class sizes in the nation
 - Oregon has the second shortest school year in the nation
 - Lowest business taxes in the nation
 - Increase the minimum tax on the largest corporations
 - 60,000 signatures are needed
 - 334 corporations paid no taxes here, but paid in other states

 - Trying to gather names of families in need
 - 700-750 families (Church provides support for 300 families, additional support comes in the form of gift cards)
 - Gift card can be used for gas, and items that aren't allowed to be purchased with food stamps
- Loves being at TL, good staff, good kids, good energy
- Volunteers makes our school go
- We have a community partnership team
 - Rekindle the relationship with Laurel Park Retirement
 - Looking for volunteer resources, bring community into school
 - Campaign about our school
 - Backpack program can be expanded
- Focus on reading
 - A ton of new books in the classrooms, thanks to BSD
 - Wants kids leaving the school year reading on grade level
- Online resources
 - AR, provided by PTC
 - School
 - Raz Kids
 - IXL math
 - Engaged NY for math
